Subject: Inclusion of Nasir Nabi Hurrah in the merit list for the Notification No. 06-PSC(DR-P) of 2023 dated 01.03.2023, for the post of Assistant Professor (Electronics), in Higher Education Department.

Whereas, Hr. Education Department vide letter No. HE/Coll/Coord/Apptt./A.P/2021 dated 05.07.2021 and No. HED-Gaz/85/2022-04 dated 13.4.2022, referred 03 posts (OM-01, RBA-01, SC-01) of Assistant Professor, Electronics to the J&K Public Service Commission for selection of suitable candidates: and

Whereas, these posts were notified vide advertisement Notification No. 06-PSC (DR-P) of 2023 dated 01.03.2023; and

Whereas, again the Hr. Education Department, vide letter No. HE-Gaz/85/2022-04 dated 24.3.2023, referred 05 posts (OM-04, ST-01) of Assistant Professor (Electronics) to the PSC for selection of suitable candidates. These posts were notified vide advertisement Notification No. 17-PSC(DR-P) of 2023 dated 15.05.2023, and

Whereas, written test of both notifications was conducted on 27.8.2023 and result of the written test was declared vide Notification No. PSC/Exam/S/2023/74 dated 03.11.2023; and

Whereas, the interview/viva voce of candidates was conducted on 7th of November, 2023, with the assistance of expert from out side of the UT, and

Whereas, the provisional selection for the post of A.P Electronics was notified vide Notification No. 92-PSC(DR-S) of 2023 dated 18.11.2023. The recommendation was sent to the Department vide letter No. PSC/DR-HE/AP-Electronics/2023 dated 08.04.2024 for further course of action; and

Whereas, Mr. Nasir Nabi Hurrah, who had applied against both the Notifications but was shortlisted only in Notification No. 17, represented before the Commission stating that since, against Notification No. 06, his merit in the written test was tied with the last meritorious candidate having

secured 39.96 marks, in terms of Rules, he was also to be called for interview for the said Notification; and,

Whereas, the issue was examined. It was found that Mr. Nasir Nabi Hurrah had also applied under notification No. 06-PSC(DR-P) of 2023 dated 01.03.2023, vide registration No. 23010638100059 and got 39.96 marks in written examination, which is equal to the merit of last short listed candidate in OM; and

Whereas, the Rule 31 (II) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, provides are as under:-


"that the candidate who have secured marks equal to those secured by the last candidate, shall also be called for the interview over and above the number of candidates short listed for oral test"

Whereas, the matter was placed before the Commission in its meeting held on 07.4.2026 and the Commission has decided as under:-

"..re-draw the merit against Notification No. 06-PSC(DR-P) of 2023 dated 01.03.2023 and include Mr. Nasir Nabi Hurrah at appropriate place at S. No. 03 having secured 39.96 points"

Now, therefore, in view of the facts and circumstances stated herein above, Mr. Nasir Nabi Hurrah shall and shall always be deemed to have been at S.No. 03 of the merit list issued vide Notification No. 92-PSC(DR-S) of 2023 dated: 18.11.2023, against Notification No. 06-PSC(DR-P) of 2023 dated 01.03.2023. Consequently, the merit list is redrawn in the following manner:
