### **Bashir Ahmad Malik**


Whereas, the objection raised in representation/complaint and consideration given is here-under:-

1	Bashir Ahmad Malik	He has stated that a candidate namely Saadia Sajad D/o Sajad Ahmad Bhat at S. No. 20 under the PHC/OM category and awarded of comparatively higher marks in the interview.	The applicant appeared in the interview Board and was awarded 6.00 points of viva voce. The points awarded to the candidates be it applicant or the candidate against


He further submitted that there appears to be serious concern regarding the benchmark disability status and assessment of the said candidate. The said candidate stammers in vocal and is not understandable, further she always needs a scribe for writing which she has been using from her basic qualifications to masters which are also reflected in the disability certificate issued by the competent medical authority. In such circumstances, it is difficult to understand how the candidate qualified personal interview and was awarded 07 marks in the interview process. Further submitted that he being a candidate in the same PHC(OM) category, possess higher academic qualification, good communication skills, and around 15 years of teaching experience at the 10+2 and higher educational level and 41 years of age, was awarded only 6 points in the interview.

whom objection has been made, is purely on the basis of performance delivered before the Board. The viva voce are held by the Interview Board strictly in light of the J & K Business Rules & Procedure 2021.
