Whereas, the posts were advertised vide Notification(s) No. 30-PSC (DR-P) of 2022 dated 30.12.2022, and No. 31-PSC (DR-P) of 2022 dated 30.12.2022, for the domiciles of Union Territory of Jammu & Kashmir, possessing the prescribed qualification; and,


