Whereas, the Higher Education Department, vide letter No. HED-GAZ/85/2022-04 dated 13.04.2022, referred four (04) posts (OM: 02, RBA:01, SC:01,) of **Assistant Professor (Architecture)**, to the J&K Public Service Commission, for selection of suitable candidates; **and,**

Whereas, the J&K Public Service Commission vide Notification No. 15-PSC (DR-P) of 2023 dated 02.05.2023, advertised the said posts for inviting applications. The cut-off date for determination of eligibility was fixed as 04.06.2023; **and,**

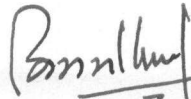
Whereas, in pursuance of Rule 42 of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, Rule 31 & 45(i) of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date, a written test was conducted on 22.10.2023; **and,**

Whereas, the result of the written examination was declared vide Notification No. PSC/Exam/S/2024/06 Dated: 27.03.2024. 12 candidates were declared to have qualified for interview provisionally. However, subsequently, only 11 candidates were found provisionally eligible and called for interview; **and,**

Whereas, the viva-voce of candidates was conducted on 23.07.2026, with the assistance of Experts from outside of the Union Territory of J&K.

Now, therefore, on the basis of the performance in the written test, interview, and other related attributes in pursuance of Rule 45(i) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure** to this Notification.

On the basis of performance in the written examination, interview and the weight-age earned in other attributes, no candidate crossed the bench mark as envisaged in Rule 50 of J&K Public Service Commission (Business & Procedure) Rules, 2021. Hence, no Provisional Select List is drawn.
