Whereas, the Higher Education Department, vide letter No. HED-GAZ/85/2022-04 dated 13.04.2022, referred two (02) posts (**OM: 01, RBA:01**) of **Assistant Professor, Fine Arts**, to the J&K Public Service Commission, for selection of suitable candidates; **and**,

Whereas, the J&K Public Service Commission vide Notification No. 15-PSC (DR-P) of 2023 dated 02.05.2023, advertised the said posts for inviting applications. The cut-off date for determination of eligibility was fixed as 04.06.2023; **and**,

Whereas, in pursuance of Rule 42 of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, Rule 31 & 45(i) of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date, a written test was conducted on 18.04.2026; **and**,

Whereas, the result of the written examination was declared vide Notification No. PSC/Exam/S/2026/49 Dated: 07.05.2026. Two candidates were declared to have qualified for interview provisionally; **and**,

Whereas, the viva-voce of candidates was conducted on 23.07.2026, with the assistance of Experts from outside of the Union Territory of J&K.

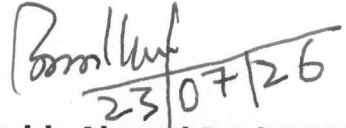
