Whereas, the Housing & Urban Development Department, vide letter No. HUD-ADM/11/2022 (C.No.129922) dated 08.04.2022, referred **two** (02) posts (**OM: 01, ALC/IB :01**) of **Assistant Architect**, to the J&K Public Service Commission, for selection of suitable candidates; **and**,

Whereas, the J&K Public Service Commission vide Notification No. 23-PSC (DR-P) of 2022 dated 08.09.2022, advertised the said posts for inviting applications. The cut-off date for determination of eligibility was fixed as 07.10.2022; **and**,

Whereas, in pursuance of Rule 42 of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, Rule 31 & 43(ii) (as applicable) of J&K Public Service Commission (Business & Procedure) Rules, 2021, , a written test was conducted on 18.04.2026; **and**,

Whereas, the result of the written examination was declared vide Notification No. PSC/Exam/S/2026/51 Dated: 07.05.2026. Six candidates were declared to have qualified for interview provisionally. However, subsequently, only 05 candidates were found provisionally eligible and called for interview; **and**,

Whereas, the viva-voce of candidates was conducted on 23.07.2026, with the assistance of Experts from outside of the Union Territory of J&K.

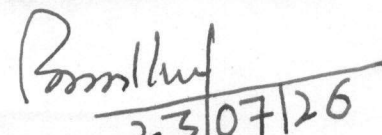
