Whereas, the J&K Science & Technology Department, vide letter No. ST/Adm/12/2019 dated 21.06.2021 referred two posts under Open Merit one each of Assistant Director (Technical Cadre) & District Coordinator S&T (Technical Cadre), to the J&K Public Service Commission, for selection of suitable candidates; **and,**

Whereas, the J&K Public Service Commission vide Notification No. 10-PSC (DR-P) of 2022 dated 26.04.2022, advertised the said posts for inviting applications. The cut-off date for determination of eligibility was fixed as 26.05.2022; **and,**

Whereas, in pursuance of Rule 42 of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, Rule 31 & 43(ii) (as applicable) of J&K Public Service Commission (Business & Procedure) Rules, 2021, a written test was conducted on 10.06.2025; **and,**

Whereas, the result of the written examination was declared vide Notification No. PSC/Exam/S/2025/47 Dated: 12.11.2025. Five candidates were declared to have qualified for interview provisionally; **and,**

Whereas, the viva-voce of candidates was conducted on 24.07.2026, with the assistance of Experts from outside of the Union Territory of J&K.

Now, therefore, on the basis of the performance in the written test, interview, and other related attributes in pursuance of Rule 43(ii) (as applicable) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure** to this Notification.
