Whereas, the Skill Development Department, vide letter No. DSD-Gen/214/2021-02 SD(86363) dated 13.03.2023, referred one (01) post under **Open Merit of Lecturer-I Computer Engineering**, to the J&K Public Service Commission, for selection of suitable candidate; **and,**

Whereas, the J&K Public Service Commission vide Notification No. 19-PSC (DR-P) of 2023 dated 26.05.2023, advertised the said post for inviting applications. The cut-off date for determination of eligibility was fixed as 29.06.2023; **and,**

Whereas, in pursuance of Rule 42 of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, Rule 31 & 43(i) of J&K Public Service Commission (Business & Procedure) Rules, 2021, (as applicable), a written test was conducted on 15.09.2024; **and,**

Whereas, the result of the written examination was declared vide Notification No. PSC/Exam/S/2024/79 Dated: 20.11.2024. Five candidates were declared to have qualified for interview provisionally; **and,**

Whereas, the viva-voce of candidates was conducted on 28.07.2026, with the assistance of Experts from outside of the Union Territory of J&K.
