Whereas, the Skill Development Department, vide letter No. DSD-Gen/214/2021-02 SD(86363) dated 13.03.2023, referred one (01) post under **SC Category of Lecturer-II (Non Engineering) Wood Technology**, to the J&K Public Service Commission, for selection of suitable candidate; **and,**

Whereas, the J&K Public Service Commission vide Notification No. 19-PSC (DR-P) of 2023 dated 26.05.2023, advertised the said post for inviting applications. The cut-off date for determination of eligibility was fixed as 29.06.2023; **and,**

Whereas, in pursuance of Rule 42 of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, Rule 31 & 43(i) of J&K Public Service Commission (Business & Procedure) Rules, 2021, (as applicable), a written test was conducted on 15.09.2024; **and,**

Whereas, the result of the written examination was declared vide Notification No. PSC/Exam/S/2024/79 Dated: 20.11.2024. Three candidates were declared to have qualified for interview provisionally; **and,**

Whereas, the viva-voce of candidates was conducted on 28.07.2026, with the assistance of Experts from outside of the Union Territory of J&K.

Whereas, upon tabulation of the points obtained in written test, interview and other attributes, it was found that none of the candidates crossed the benchmark envisaged in Rule 50 of J&K Public Service Commission (Business & Procedure) Rules, 2021.

Now, therefore, as a consequence of the facts and circumstances detailed here-in-above, the provisional Select list cannot be drawn and issued against the said post. The merit of the eligible candidates who appeared in the interview is enclosed as **Annexure** to this Notification.

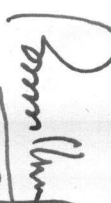
