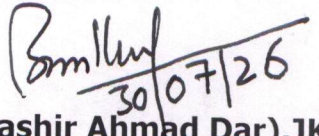
Whereas, the Health & Medical Education Department, vide letter No's, ME-Gztd-525/2023-01 (CC: 7331789), dated 09.07.2024, 30.05.2025 & 29.07.2025 referred One (01) post (**OM:01**) of Professor, Cardio Vascular Thoracic Surgery, to the J&K Public Service Commission, for selection of suitable candidate; **and,**

Whereas, the said post was advertised vide Notification No. 21-PSC (DR-P) of 2025 dated 31.12.2025. The cut-off date for determination of eligibility was fixed as 04.02.2026; **and,**

Whereas, in pursuance of Rule 44(iv)(a) of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date, interview of two candidates was scheduled to be conducted on 30.07.2026 with the assistance of Experts from outside of UT; **and,**

Whereas, the eligibility of candidates was re-checked in consultation with the Experts. It was observed that the candidates did not meet the condition (i) & (ii) as laid down in the "experience" column of the Notification No. 21-PSC (DR-P) of 2025 dated: 31.12.2025.

Now therefore, the candidature of the two candidates is hereby rejected. They may represent before the Appellate Authority within 10 days in case they choose to do so. No representation shall be accepted after stipulated time.
