Whereas, vide this commission's notice dated **23.07.2019**, the interview notice for the post of **Assistant Professor, Sociology in Higher Education Department**, was issued to the provisionally short listed candidates and the left out candidates were asked to represent before the commission within a period of **10 days** from the issuance of the notice, in case they feel aggrieved with regard to the cutoff merit indicated against each category or by the non inclusion/rejection of their names in the said notice or as the case may be: and


Whereas, in furtherance to notice dated **23.07.2019**, four candidates namely 1). **Mrs. Meenakshi Chandan D/O Mr. Yograj Chandan**, 2). **Mrs. Cheshta Sharma D/O Mr. RP Sharma**, 3). **Mrs. Swechha Singh D/O Mr. Rajinder Prasad Singh** and 4). **Mr. Konchok Paldan S/O Mr. Konchok Tamphel** submitted representations about their grievances, which were put up before the **Appellate Authority of the Commission** constituted for the purpose for disposal and decision; and

Whereas, the representations were disposed of by the **Appellate Authority** of the commission and as per the decision made by the **Appellate Authority** in each of the representations the cut off merit as indicated in the Notice Dated **23.07.2019**, was reworked and it was **changed from 27.97 to 28.08 under ST Category** as the candidate at S.No 04 in above para was awarded additional **01** point for his Teaching Experience and **no Change in Cut off merit was Observed in case of the OM category** as indicated in the earlier notice as none of the candidates from S.No. 01 to 03 in above para could cross the last cut off merit under Open Merit even after the award of additional points for their Teaching Experience ; and

Whereas, the revised cutoff merit under Open Merit category necessitated the inclusion of **Mr. Konchok Paldan S/O Mr. Konchok Tamphel** in the Provisional list of Shortlisted candidates to be called for interview and by inclusion of his name in the provisional list of Shortlisted candidates for interview, the name of the last candidate in order of merit in the notice Dated 23.07.2019 shall be excluded from the said interview notice.

Now, therefore, **Mr. Konchok Paldan S/O Mr. Konchok Tamphel** is hereby called for interview for the post of **Assistant Professor, Sociology in Higher Education Department, the interviews of which shall be held** at J&K, Public Service Commission Office Complex, **Solina , Srinagar at 9.30 A.M on 05.08.2018 along with other shortlisted candidates and the name of Mr. Tsering Nordon S/O Mr. Phuntsog Wangdan** shall and shall always be deemed to have been deleted from the interview notice dated **23.07.2019**.
