Subject: Interview/Rejection notice for the post of Assistant Professor, **Geography** in Higher Education Department.

Notice

Dated: 20.10.2020

Whereas, the J&K Public Service Commission, vide Notification **No.10-PSC (DR-P) of 2017 dated 27.10.2017** invited online applications on prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification for the **10 posts (OM: 04, RBA: 02, SC: 01, ST: 01, SLC:01 and ALC:01)** of Assistant Professor **Geography** in Higher Education Department and in response to the above said Notification, the Commission received **292** applications in the said discipline; and

Whereas, the verification/ scrutiny of the documents was conducted by the Screening Committee constituted for the purpose and the documents of some candidates were found deficient and accordingly the deficiency notice was issued vide Notice dated **03.06.2019**; and

Whereas, the deficient documents were received from the candidates in response to notice dated **03.06.2019** and the said documents were again verified/scrutinized by the Screening Committee for short listing of the candidates for interview; and

Whereas, the Rule 51 of J&K Public Service Commission (Business and Procedure) Rules, 1980 as amended from time to time provides for the shortlisting of candidates for interview in the ratio of 1:3 and as such total **12 candidates** are to be shortlisted under OM Category for **04** advertised posts, **06 candidates** under RBA Category for two advertised posts and 03 candidates each under ST, SC, ALC and SLC Category for **01 post** advertised against each; and

Whereas, one candidate namely Ms. Saima Ali D/o. Ali Mohammad Ganie who had applied for the post of Assistant Professor, Geography under ALC Category was called for interview under ALC Category on 06.11.2019; and

Whereas, during the course of verification of the documents at the time of interview, it was found that she had applied under ALC Category but could not produce the requisite category certificate before the Screening Committee; and



Whereas, as per the notice dated 10.10.2019, the candidature of the candidate was provisional and she was not allowed to participate in interview on the grounds of not producing the ALC Category Certificate.

Whereas, the last cut off merit for shortlisting under ALC category was notified as 25.53 and the candidate next in order of merit as per records is Shri Ajay Kumar S/O. Shri Tirath Ram under ALC category; and

Whereas, the Commission has decided to hold afresh all interviews which were conducted by the erstwhile Commission between 31.10.2019 and 21.11.2019 and a notice to this effect has been issued vide PSC/DR/Pending Selections/2020, dated 15.10.2020.

Now therefore, the candidature of Ms. Saima Ali D/O. Ali Mohammad Ganie is hereby rejected and her name shall and shall always be deemed to have been deleted from the interview notice for the post of Assistant Professor, Geography and it is further notified that Shri Ajay Kumar S/O. Shri Tirath Ram under ALC Category is hereby called for interview for the post of Assistant Professor, Geography. The venue, date and time of interview of candidates for the post of Assistant Professor (Geography) shall be notified separately.
