
- Whereas, the J&K Public Service Commission conducted the Written test for the posts of Medical Officer (Allopathic) in H&FW Department on 01.11.2020; and
- Whereas, in pursuance of Rule 12B of the Jammu & Kashmir Public Service Commission (Conduct of Examination) Rules, 2005, as amended upto date, the official key was notified and uploaded on the official website of the Commission for information of the candidates on 01.11.2020 at 3pm, inter-alia notifying that, if any candidate feel that the key to any of the questions is wrong/incorrect, he/she may prefer a representation/objection on the prescribed proforma to the Controller of Examinations within a period of three days i.e upto 04.11.2020 (5:00pm) from the date of its notification, alongwith documentary proof /evidence and the fee of Rs 500/- per question; and
- Whereas, in response to the said notification, number of representations were received by the J&K Public Service Commission; and
- Whereas, all the objections/representations were referred to the Committee of Experts as envisaged in Rule 12B of the J&K Public Service Commission (Conduct of Examination) rules, 2005, as amended from time to time, for Independent Expert opinion; and
- whereas, the Independent team of Experts, have recommended the following changes in seven questions of the provisional official key:-
