
1. Whereas, the J&K Public Service Commission conducted the Written test for the posts of Veterinary Assistant Surgeon in Animal & Sheep Husbandry Department on 22.11.2020; and
2. Whereas, in pursuance of Rule 12B of the Jammu & Kashmir Public Service Commission (Conduct of Examination) Rules, 2005, as amended upto date, the official key was notified and uploaded on the official website of the Commission for information of the candidates on 22.11.2020 at 3pm, inter-alia notifying that, if any candidate feel that the key to any of the questions is wrong/incorrect, he/she may prefer a representation/objection on the prescribed proforma to the Controller of Examinations within a period of three days i.e upto 26.11.2020 (5:00pm) from the date of its notification, alongwith documentary proof /evidence and the fee of Rs 500/- per question; and
3. Whereas, in response to the said notification, number of representations were received by the J&K Public Service Commission; and
4. Whereas, all the objections/representations were referred to the Committee of Experts as envisaged in Rule 12B of the J&K Public Service Commission (Conduct of Examination) rules, 2005, as amended from time to time, for Independent Expert opinion; and
5. whereas, the Independent team of Experts, have recommended changes in the provisional official key;

Now, therefore, in view of the above and on the basis of opinion of the independent team of experts, it is hereby notified that:-

- a) The changes recommended by the Committee of Experts is hereby adopted and the Final Official Key is annexed as **Annexure "A"** to this notification and the marks allocated to deleted questions shall be redistributed equally amongst the rest of the questions on pro-rata basis at the time of calculation/compilation of award sheet before

the declaration of the result in terms of Rule 12 of the J&K Public Service Commission (Conduct of Examination) Rules, 2005 as amended upto date;

- b) The amount deposited @ Rs 500/- per question is also hereby released in respect of genuine/correct representations and same shall be transferred through RTGS in individual account of candidates.


