Subject: Select List for the posts of Assistant Professor (Clinical Biochemistry) in Higher Education Department.

Notification No. 03- PSC (DR-S) of 2020 Dated: 11.12.2020

Whereas, the Higher Education Department referred 20 posts [OM:11, RBA:04, SC:02, ST:02 & ALC:01] (Horizontal reservation PHC-01 post) of Assistant Professor (Clinical Bio-chemistry) to the Public Service Commission for being filled up from amongst the suitable candidates; and,

Whereas, the Commission notified these posts vide Notification No. 10-PSC (DR-P) of 2017 dated 27.10.2017; and,

Whereas, in response to the above notification, 142 applications were received. Out of these, 35 eligible candidates were shortlisted and called for interview; and,

Whereas, the interview of the shortlisted candidates was conducted on 19.11.2020 & 20.11.2020 with the assistance of experts from outside the state; and,

Whereas, 03 posts under RBA category, 02 posts each under SC & ST category and 01 post under ALC category left vacant due to non-availability of candidates.

Now, therefore, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, the merit of the candidates who have appeared in the interview is enclosed as **Annexure-"A"** to this Notification.

Consequent upon the above, the **select list** of the candidates against the available posts is given in **Annexure-B** to this Notification.

Note:-

- 1. The Commission reserves the right to have certificates/documents of the candidate verified, if it is at any stage found expedient to do so. The Selection of the candidate is purely provisional and is subject to the outcome of writ petitions pending before any competent Court of law.
- 2. In pursuance of Rule 51 of J&K PSC (Business & Procedure) Rule, 1980 and as reiterated by the Commission in the 20th extra ordinary meeting held on 20.06.2019, candidates having NET are entitled for points only from the highest qualification amongst M.Phil/Ph.D and where Ph.D itself is consumed towards eligibility the candidates are not entitled for any points.

3. The select list is provisional. Any objection may be submitted to the Commission within one week for examination and disposal. No claim will be entertained after one week from the date of issuance of Notification.
