Whereas, the J&K Public Service Commission, vide Notification No.10-PSC (DR-P) of 2017 dated 27.10.2017 invited online applications on prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification for the 20 posts (OM: 11, RBA: 04, SC: 02, ST: 02 and ALC:01) of Assistant Professor Clinical Bio-Chemistry in Higher Education Department and in response to the above said Notification, the Commission received 142 applications in the said discipline; and

Whereas, the verification/ scrutiny of the documents was conducted by the Screening Committee constituted for the purpose and the documents of some candidates were found deficient and accordingly the deficiency notice was issued vide Notice dated 24.05.2019; and

Whereas, the deficient documents were received from the candidates in response to notice dated 24.05.2019 and the said documents were again verified/scrutinized by the Screening Committee for short listing of the candidates for interview; and

Whereas the Higher Education Department Vide letter Dated 28.05.2019 clarified that the Minimum Prescribed Qualification of M.Sc. Bio-Chemistry is equivalent to M.Sc. Clinical Bio-Chemistry for the post of Assistant Professor Biochemistry on the basis of which the candidates with PG in Bio-chemistry were to be considered for the post of AP Clinical Bio-chemistry; and

Whereas Hon'ble High Court in WP(C) No 2138/2019, CM No. 4035/2019 titled Mehraj Ud Din and others Vs State and others has directed that the selection to the post of Assistant Professor Clinical Bio-chemistry shall be made strictly as per Notification Dated 27.10.2017 and not as per the

Communication No. HED/GN/Gazetted/Equi/2018 dated 28.05.2019 impugned in the petition ; and

Whereas, now only candidates having post-graduation in Clinical Biochemistry have been considered for shortlisting in terms of the interim directions of the Hon'ble High Court in WP(C) No 2138/2019, CM No. 4035/2019 titled Mehraj Ud Din and others Vs State and others; and

Whereas, the short listing of the candidates was conducted as per provisions of Rule **51 of J&K Public Service Commission (Business and Procedure) Rules , 1980** as amended from time to time, which provides for weightage to be given to the Academic performance, outreach and extra –curricular activities, special attributes and teaching skills constituting total **57 points, (on pro-rata basis)** with the break-up tabulated as under:
