Whereas, the Higher Education Department vide communication No. Edu/Coll/apptt./A.P/2014 dated 19.05.2014, had referred 02 (OM=01, RBA=01, ) posts of Assistant Professors in the discipline of Seed Technology to the J&K Public Service Commission for being filled up through direct recruitment from amongst the eligible/suitable candidates in terms of SRO-124 dated 21.04.2014; and

whereas, the J&K Public Service Commission, vide Notification No. 12-PSC(DR-P) of 2014 dated 29.5.2014 invited applications on prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification. In the said notification it was inter alia mentioned at Note-2 that the candidates who have already applied in response to Notification No. 09-PSC(DR-P) of 2013 dated 23.05.2013 for the above mentioned post(s) need not apply subject to the fulfillment of eligibility requirement as laid down in SRO-124 dated 21.04.2014; and

Whereas, in response to the above said Notifications, the Commission received 11 applications; and

whereas, after security of the documents, the short-listing of the candidates is to be done in terms of Rule 40-II (b) of J&K Public Service (Business & Procedure) Rules 1980 on the basis of percentage of marks obtained in the basic prescribed qualification and weightage to be given to higher qualification; and

Whereas these applications were scrutinized; and
