The candidates, who qualified the Written Test, are advised to submit hard copy of their online application form along with the fee receipt at J&K PSC office, Solina, Srinagar/Resham Ghar Colony, Bakshi Nagar, Jammu or send the same to the address of the Controller of Examinations, J&K Public Service Commission, Resham Ghar Colony Bakshi Nagar, Jammu, by registered post. Only such identified

documents as have been posted by or before 24.11.2018 and delivered in the Commission by 27.11.2018 shall be considered.

- v. The candidates shall produce their original certificates/testimonials on the date of oral test/Viva-Voce.
