Whereas, the Commission notified these posts vide Notification No. 01-PSC(DR-P) of 2018 dated:17.01.2018; and

Whereas, selections were made vide Notification No.46-PSC(DR-S) of 2018 dated 05.10.2018; and

Whereas, Dr. Beena Jad D/O Sh. Avtar Krishan Jad R/O 120 Lower Laxmi Nagar, Sarwal, Jammu was also a candidate for one post and claimed age relaxation given to in-service candidates on the grounds that she was engaged on contractual basis; and

Whereas, on scrutiny of documents her engagement was on Academic basis and not on contractual basis as claimed by her; and

Whereas, academic arrangement as in-service candidate is beyond the purview of Government Order No.102-GAD of 2007 dated 27.01.2017 and devoid of any merit.

Now, therefore, the candidature of Dr. Beena Jad D/O Sh. Avtar Krishan Jad R/O 120 Lower Laxmi Nagar, Sarwal, Jammu is hereby rejected ab-initio.
