Whereas, Higher Education Department referred 12 posts [OM-06, RBA-03, SC-01, ST-01 & ALC-01] of Assistant Professor in the discipline of Information Technology vide letter No. Edu-Coll/774/2013 dated 22.03.2013 read with letter No.HE-Coll/Coord/Apptt./A.P/2014 dated 19.05.2015 to the J&K Public Service Commission for being filled up from amongst the suitable candidates; and

Whereas, J&K Public Service Commission advertised these posts, vide Notification No. 12-PSC(DR-P) of 2014 dated 29.05.2014, in response whereof 189 candidates submitted their applications, out of whom 64 candidates were called for interview conducted on 28.08.2018 & 29.08.2018 with the assistance of the Subject Matter Experts from outside the State.

Whereas, 10 more candidates were allowed to participate in the interview on the directions of the Hon'ble High Court passed in OWP No.1562/18, MP No.01/2018 titled Syed Mohsin Saif & Others v/s J&K PSC and SWP No.1915/2018, IA No.01/2018 titled Junaid and another v/s State of J&K and Others. The operative part of the directions are reproduced as under:-

**OWP NO. 1562/18 MP NO. 01/2018 TITLED SYED MOHSIN SAIF & ORS V/S J&K PSC**

*“ Meanwhile subject to the objections respondents are directed to provide fresh application forms to the petitioners and also conduct their interview for the post of Assistant Professor in the discipline of Information Technology which is scheduled to be held on 28<sup>th</sup> & 29<sup>th</sup> of August, 2018. However, mere participation in the selection process shall not confer any right on the petitioners. Result of the petitioners shall also not declared till further orders from this court.”*

**SWP NO. 1915/2018 IA NO. 01/2018 Titled Junaid and another V/s STATE OF J&K AND Others.**

*“MP is disposed of with a direction to the respondents to allow the petitioners to appear in the interview to be conducted w.e.f 28<sup>th</sup> of August, 2018 for the post of Assistant Professor in the*

***discipline of Information Technology at his own risk and responsibility.”***

On the basis of the overall performance in the interview and in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980, as amended from time to time, the consolidated list of the candidate(s) who appeared in the interview has been prepared which is enclosed as Annexure-“A” to this Notification.
