Whereas, the Health & Family Welfare Department referred 17 posts [OM-08, RBA-04, SC-02, ST-02 & ALC-01] of Consultant Anesthesiology to the Public Service Commission for being filled up from amongst the suitable candidates.

Whereas, the Commission notified these posts vide Notification No. 05–PSC(DR-P) of 2018 dated:13.03.2018; and

Whereas, in response to the above notification, 110 applications were received and out of which 91 candidates were found eligible and called for interview; and

Whereas, the interview of the eligible candidates was conducted on 22.10.2018 & 23.10.2018 with the assistance of experts from outside the state; and

Whereas, one candidate namely Mr. Naseer Ahmad Dar B.D. No.79 was remained absent on the date of interview. Now he has filed a writ petition SWP No.2632/2018, IA No.01/2018 titled Naseer Ahmad Dar v/s Chairman, Public Service Commission & another and Hon'ble High Court has directed the Commission to reserve one post for the petitioner till the outcome of the final decision by the Court. The operative part of the court orders reads as under:-

***“... in the meanwhile, respondents shall take decision with reference to the claim of the petitioner on the stated facts/grounds and decide the same within a period of two weeks. Till next date of hearing before the Bench, the post against which the petitioner has applied shall not be filled up.”***

Whereas, one post each under SC Category and ALC category left vacant due to non-availability of candidates. Two posts under RBA category also left vacant due to non-availability of candidates.

Now, therefore, on the basis of performance in the interview and the weightage earned in respect of academic merit, qualifications, experience etc. and the overall performance, the Merit of the candidates who appeared in the interview is enclosed as **Annexure-“A”** to this Notification.

Consequent upon the above, the **select list** of the candidates against the available post is given in **Annexure-B** to this Notification.

**Note:-**

The Commission reserves the right to have certificates/documents of the candidate verified, if it is at any stage found expedient to do so. The Selection of the candidate is purely provisional and is subject to the outcome of writ petitions pending before any competent Court of law.
