Subject: Select List for the posts of Lecturer 10+2 (Information Technology) in School Education Department.

Notification No. 40 - PSC (DR-S) of 2019
Dated: 23.05.2019

Whereas, in continuation of the Notification No.08-PSC (DR-S) of 2018 dated 15.02.2018, 10 posts of Lecturer (10+2) Information Technology were kept withheld vide Hon'ble High Court order dated 03.06.2016 in SWP No.957/2016 & M.P. No.1/2016 titled Vikas Sawhney and Others V/S State of J&K & Others:-

"..... Meanwhile subject to the objections and till next date before the bench, respondent No.2 is directed to allow the petitioners to participate in the selection process for the post of Lecturer 10+2 in the discipline of Information Technology in School Education Department at their own risk and responsibility. However, mere participation shall not create any right in favour of the petitioners and their result shall not be declared till further orders. It is further provided that the process of ten posts of Lecturer 10+2 in the discipline of Information Technology shall not be finalized but the respondents may go ahead with the selection process. However, selection of rest of the posts shall remain subject to the outcome of the writ petition."

Whereas, 01 more post under Open Merit was kept withheld on the directions of the Hon'ble High Court in SWP No. 2556/2017 titled Roaf Ahmad and Others Vs State of J&K & Ors. dated:01.02.2018. The operative part of the direction is reproduced as under:-

"....Meanwhile, it is directed that respondent No.2 shall allow the petitioner to participate in the interview/viva-voce to be conducted on 05.02.2018, 06.02.2018 & 07.02.2018 for the post of Lectures in Information Technology provided the petitioner has qualified the written examination. However, result of the petitioner shall not be declared till further orders from the Court. The issue as to whether the qualification possessed by the petitioner is relevant qualification for the prescribed post shall be declared later."

Whereas, the Hon'ble High Court passed an order on 10.04.2019 in SWP No.957/2019, IA No.01/2018 & 01/2016 titled Vikas Sawhney and Others V/S State of J&K & Others, the operative part of the direction is reproduced as under:-

“After having heard learned counsel for the parties and considering the Jammu & Kashmir School Education (Gazetted) Service Recruitment rules, 2010, this petition is not maintainable because the qualification prescribed for the post of Lecturer in Information Technology is M.Sc. Information technology from the recognized University as given in Schedule II. These Rules were notified under SRO 481 dated 30.12.2010.

..... this writ petition is without any substance and is, accordingly, dismissed.”

Now, therefore, on the basis of the performance in the interview coupled with the weight-age accorded to the marks secured in written test in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, **the result of 10 the candidates figuring in the select list approved by the Commission in its meeting held on 15.02.2018** is given in **Annexure-A** to this Notification. The final merit position of all the selected candidates will remain subject to the outcome of the decisions of the Hon’ble Court. Further, one post is kept withheld on account of directions of the Hon’ble High court in SWP No. 2556/2017 titled Roaf Ahmad and Others Vs State of J&K & Ors.

Note:-

1. The Commission reserves the right to have certificates/documents of the candidate verified, if it is at any stage found expedient to do so. The Selection of the candidate is purely provisional and is subject to the outcome of writ petitions pending before any competent Court of law.
2. The select list is provisional. Any objection may be submitted to the Commission within five days for examination and disposal. No claim will be entertained after five days from the date of issuance of Notification.
