**Subject: Select List for the posts of Lecturer ENT (GMC Srinagar) in Health & Medical Education Department.**

**Notification No. 34 – PSC (DR-S) of 2018**  
**Dated: 03.07.2018**

Whereas, the Health & Medical Education Department referred 02 posts of Lecturers in Govt. Medical College, Srinagar, one each under OM & RBA Category [OM-01 & RBA-01], in the discipline of ENT, vide letter No. ME/Gaz/154/2012 dated 15.06.2017 & ME/Gaz-187/2014-I dated 15.06.2017, to the J&K Public Service Commission, for being filled up from amongst the suitable candidates; and

Whereas, the J&K Public Service Commission advertised these posts, vide Notification No. 05-PSC (DR-P) of 2017 dated 10.07.2017, in response whereof 19 candidates submitted their applications, out of whom, 15 candidates were found to be eligible and, accordingly, called for interview which was conducted on 20.06.2018, with the assistance of the Subject Matter Experts; and

Whereas, two more candidate namely Mr. Danish Zamir Andrabi and Mr. Haris Manzoor Qadri were called for interview in compliance of the order dated 07.06.2018, passed by the Hon'ble High Court in SWP No.1299/2018, titled Dr. Danish Zamir Andrabi Vs State of J&K and another, operative part whereof reads as under:-

***“In the meantime subject to objections for the other side and till the next date of hearing before the Bench, it is directed as under:***

- I. The impugned notification dated 20<sup>th</sup> of February, 2018 issued by the respondent Commission, in so far as it relates to rejecting the candidature of the petitioners, shall stay;***
- II. The respondent Commission shall allow the petitioner to compete in the process of selection;***
- III. Selection, if any, against the post(s) in question shall remain subject to outcome of the writ petition.”***

Whereas, on the scheduled date, only 15 candidates appeared before the Interview Board, while as Petitioner No.1 Mr. Danish Zamir Andrabi and another candidate namely Sajad Ahmad Ahanger under OM category did not appear.

On the basis of the overall performance in the interview and other related parameters, envisaged under Rule 51 of the J&K Public Service Commission

(Business & Procedure) Rules, 1980, as amended from time to time, the consolidated list of the candidate(s) who appeared in the interview is enclosed as Annexure-“A” to this Notification.

Consequent upon the above, **Ms. Aleena Shafi Jallu D/O Mohd. Shafi Jallu R/O 12 Green Avenue Sector-B New Airport Road Peerbagh, who secured 61.91 points**, is declared to be selected against the post under Open Merit. The other post has remained vacant, as no candidate under RBA category, has fulfilling the minimum prescribed bench mark of 45% out of the total weightage points earmarked for assessment.

The Commission reserves the right to have certificates/documents of the candidates verified, if it is at any stage found expedient to do so. This shall be subject to the final outcome of the writ petition in SWP No.1299/2018 titled Dr. Danish Zamir Andrabi VS State of J&K and another and other writ petition(s) pending before any competent Court(s) of law.
